



Sale Rules For Consignors for 2010

*Please read and familiarize yourself with the terms and conditions of this sale.
As a consignor, you are bound by these terms and conditions, whether you read them or not!*

1. Sale is open to registered Morgans, Saddlebreds and Tenn. Walking Horses only, or to Morgans, Saddlebreds and Tenn. Walking Horses with registration applied for.
2. A copy of the registration papers must accompany the consignment form.
3. A breeding certificate must accompany a bred mare who is consigned.
4. 10% commission will be charged on sales of horses.
5. "No sale" consignments will be charged **\$25.00 (minimum) or 5%** of the final bid.
(Whichever is greater?)
6. **Transfer of ownership will be the responsibility of the buyer.** (*Signed registration papers will be given to the buyer after the sale, if paid by cash. Registration papers will be mailed to the buyer after check has cleared, if paid by check.*)
7. Checks will be mailed out within 30 days after the sale date.
8. Catalog order to be the discretion of the management. Sufficient time will be allowed between your consigned horses.
Horses not in the catalog will sell last. It is to your advantage to be in the catalog in order to receive advance publicity for your horse.
9. Horses shall be in the barn by 9:00 a.m. CST the day of the sale in order for prospective buyers to see and inspect them.
The barn will be open at 12:00 noon CST on Friday, the day before the sale.
10. **Horses will not be sold unless all paperwork is completed and in the sale file.**
Paperwork required is:
Original registration papers
Completed and signed transfer, (Which must be signed by all parties whose names appear on the papers)
Health certificate (with Illinois permit number if it is an out of State Horse)
And current negative Coggins test (for Equine Infectious Anemia).
11. A consignment fee of \$60.00, plus a \$100.00 "No Show" fee must accompany each entry.
Checks are to be payable to MVMHC. The \$100.00 check for the "**No Show**" **fee should be on a separate check**, which will be returned to you after your horse goes through the ring.
Consignors will not be charged the \$100.00 "No Show" fee for cancellations of horse due to illness or injury, provided said cancellation is accompanied by a veterinary statement.
Substitutions are allowed.
12. No pre-sale transactions may be made on the sale grounds or in the barn after the horses are checked in. **** NO EXCEPTIONS **!!!**
13. Buyer has the right to have a veterinary examination before the horse leaves the sale premises, (at the buyers own expense).
14. All horses are sold based on the information in the footnotes which are provided by you, the consignor. It shall be the responsibility of the consignor to correct any footnotes by advising the sale manager or the auctioneer.
15. All horses are to be halter broke and sold with a usable halter and lead rope, which must remain with the horse after the sale. (Seller will be billed if this is not provided.)
16. Horses shall belong to the buyer when they leave the ring. You, the seller, shall be obligated to return the horse to the proper stall and to contact the buyer.
17. Catch riders and grooms are available for a nominal fee.
18. All horses must have bedding in the stalls. (**BEDDING WILL NOT BE SUPPLIED BY MVMHC**) ** Bedding will be available on grounds at owners expense.**
19. MVMHC. IS NOT RESPONSIBLE FOR THEFT OR INJURY.
20. **NO DOGS WILL BE ALLOWED**
